The Board of Directors at The Windsor Women Working with Immigrant Women (W5) is seeking caring and passionate individuals to join our board. Directors are appointed to two year terms and can serve up to three terms for a total of 6 years.

## **About the W5 Board of Directors**

We are a mid-sized board (averaging 10 members in the last three years) that meets monthly and is supported by three committees (Executive, Governance and Finance). Our membership represents a diversity of identities, ages, skills, professions, and lived experiences. We operate as a policy governance board, and our main responsibilities are to direct the agency's strategic priorities, be accountable for its finances, and oversee its management through our chief executive officer.

#### About W5

We want every newcomer, their family, and women newcomers in particular, to have access to the tools and support they need to achieve their goals. We equip the newcomers we support to build community, create financial security, develop English language skills, and support their mental well-being. We do that through settlement, employment, entrepreneurship, child care and mental wellness programs. The W5 is a charitable not-for-profit agency that was founded in 1981 by a group of dedicated women to serve new Canadians. We are funded primarily through government grants.

The W5 is committed to excellence in the service we provide to the people we support - a robust, diverse, and engaged board plays a critical role to supporting that commitment. Your membership on our board will ensure that all newcomers who access our programs - and in particular women newcomers and families - are equipped with the skills, tools and support they need to participate fully in Canadian life.
